



Extended Care Program 2021–2022

We are very happy to offer the Extended Care Program (ECP) for our children once again.

Some changes to the program were necessary for the 2020–2021 school year in keeping with COVID-19 health and safety precautions. We are going to maintain the same protocols and program for 2021–2022.

We can enroll a limited number of children in the Extended Care Program in order to maintain safe social distancing. Therefore, **acceptance is on a FIRST–COME, FIRST–SERVED basis**. Once the program fills, we will place children on a waiting list according to the dates registrations come in. Additionally, to keep it fair for those who are on the waiting list, commitment to the program *must be for an entire semester*.

Before School:

- We will not have a morning program because of the strict mandates for safety, screening upon entrance, and staffing limits. We may re-evaluate this during the year.

After School:

- We will offer **one** after-school option with pickup by **4 p.m.**
- We cannot go beyond the 4 p.m. pickup time because of staffing limitations.
- We understand that once in a great while there are unexpected circumstances beyond one's control; however, if a child is chronically late being picked up, their spot would go to the next student on the waiting list.
- We are not able to offer occasional use because of social distancing guidelines and staffing.

Rates:

- A non-refundable enrollment fee of \$30 per family is due to Nazareth Elementary with your application.
- See attached sheet for monthly rates.
- There is an additional fee of \$35 per day for each child picked up after 4 p.m.
- **NOTE: *Children scheduled to be picked up at dismissal time who are not picked up by 3 p.m. will be taken to ECP. A fee of \$35 per occurrence will be charged.***

You will be charged the monthly rate if this happens consistently.

Closures:

- ECP will not operate whenever school is closed. No refunds will be given for weather–related closings, such as snow days, or if a child does not attend on a particular day.

Other Information:

- We maintain a sign-out system for security.
- All financial accounts must be current in order to participate in ECP and retain your child/ren's spot.

Extended Care Program Information and Rate Schedule 2021–2022

The Extended Care Program (ECP) is an after-school childcare service operated by Nazareth Elementary School. ECP is a ten-month program, beginning the first full day of each school year for students enrolled at Nazareth Elementary. This service is a convenient program providing students with supervised care, age-appropriate activities, and a homework area.

Extended Care Program (ECP) rates are the same for all ages.

*** Acceptance is on a FIRST–COME, FIRST–SERVED basis because of social distancing limits.**

Guidelines and Policies:

- ECP charges are added monthly to your FACTS account.
- A non-refundable \$30 enrollment fee per family is due to Nazareth Elementary with your application.
- An additional fee of \$35 per day, per child, is charged for children not picked up by 4 p.m.
- Children who are picked up chronically late will be unable to continue attending ECP.
- NOTE: Children scheduled to be picked up at dismissal time who are not picked up by 3 p.m. will be brought to ECP. A \$35 fee will be charged.
- ECP operates only when Nazareth Elementary is open.
- There are no refunds for weather-related school closings, absences, or participation in after-school activities or clubs.
- **FACTS accounts must be current in order to participate in ECP and retain a child’s spot.**
- A sign-out system is maintained for security purposes. An authorized adult must pick up each student every day.
- ECP commitment is for the entire semester.
